ORDINANCE NO. 07-14

**AN ORDINANCE AMENDING THE LISLE-WOODRIDGE
FIRE PROTECTION DISTRICT ORDINANCE #01-10
(NON-RESIDENT EMS BILLING)**

WHEREAS, the Lisle-Woodridge Fire District (the "District"), is a fire protection district duly organized under the laws of the State of Illinois; and

WHEREAS, the Board of Trustees of the District has full power to pass all necessary ordinances, and rules and regulations for the proper management and conduct of the business of the Board of Trustees of the District for carrying into effect the objects for which the District was formed under 70 ILCS 705/6; and

WHEREAS, on October 23, 2001, the Board of Trustees adopted its Ordinance 99-11 entitled "An Ordinance Amending Ordinance No. 84-7, No. 89-7, No. 95-8, No. 96-8, No. 97-10, No. 98-6 and Imposing fees for Emergency Medical Transportation of Non-District Residents".

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Lisle-Woodridge Fire Protection District, DuPage County, Illinois, as follows:

Section 1. The Board of Trustees hereby amends its Ordinance No. 01-10 by amending the fee schedule located in the final recital clause to read as follows:

| ALS 1 Emergency with transport | 1000.00 |
| ALS 2 Emergency with transport | 1200.00 |

Section 2. That the provisions of this Ordinance shall be in full force and effect upon adoption.

Section 3. That this Ordinance shall supersede any ordinances, resolutions or motions or parts of ordinances, resolutions or motions in conflict with any part herein, and any such ordinances, resolutions, or motions or parts of such are hereby repealed to the extent of any conflict.

Section 4. If any section, paragraph or provisions of this Ordinance shall be held invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this Ordinance.
