

ORDINANCE NO. 08 - 07

ORDINANCE LEVYING AND ASSESSING TAXES OF
LISLE-WOODRIDGE FIRE PROTECTION DISTRICT
DUPAGE AND WILL COUNTIES, ILLINOIS
FOR 2008

BE IT ORDAINED by the Board of Trustees of the Lisle-Woodridge Fire Protection District as follows:

Section 1: That the sum of *FIFTEEN MILLION, FIVE HUNDRED FIFTY-NINE THOUSAND, NINE HUNDRED (\$15,559,900.00) DOLLARS* be and the same is assessed and levied from and against all taxable property within the limits of the said Lisle-Woodridge Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2008, and are to be applied in liquidation of the appropriations heretofore made by Ordinance adopted by the Board of Trustees of the Lisle-Woodridge Fire Protection District at a meeting thereof regularly convened and held on November 25, 2008, and duly published as provided by law and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy", as follows:

CORPORATE FUND

Amount to be Raised by Tax Levy \$7,090,790

The foregoing amount is hereby levied for general corporate purposes.

TORT LIABILITY FUND

Amount to be Raised by Tax Levy \$1,300,000

The foregoing amount is hereby levied for tort liability purposes under and pursuant to the provisions of 745 ILCS 10/9-107.

AUDIT FUND

Amount to be Raised by Tax Levy \$6,000

The foregoing amount is hereby levied for audit expense purposes.

AMBULANCE FUND

Amount to be Raised by Tax Levy \$5,720,410

ILLINOIS MUNICIPAL RETIREMENT FUND
