

**ORDINANCE #09-03**

**AN ORDINANCE AMENDING ORDINANCE #95-20 CHARGING NON-RESIDENTS FEES FOR EMERGENCY RESPONSE SERVICES BY THE LISLE-WOODRIDGE FIRE DISTRICT FOR VEHICLE FIRES WITHIN THE LISLE-WOODRIDGE FIRE PROTECTION DISTRICT**

**WHEREAS**, the Illinois Fire Protection Act grants to the Board of Trustees of a fire protection district the authority to “assess a charge for all services rendered by the district against persons, businesses and other entities who are not residents of the fire protection district” Intergovernmental Cooperation Act (70 ILCS 705/11); and

**WHEREAS**, the Lisle-Woodridge Fire Protection District (the “District”), DuPage and Will Counties, Illinois, is a fire protection district duly incorporated under the laws of the State of Illinois (70 ILCS 705/1); and

**WHEREAS**, the District renders emergency responses to fires within the boundaries of the District; and

**WHEREAS**, the District responds to vehicle fires on public and private property within the District in the performance of its obligations to the general public; and

**WHEREAS**, such emergency responses to vehicle fires within the District incur costs to the Districts and its residents; and

**WHEREAS**, the Board of Trustees finds that it is in the best interest of the District to charge all non-residents for costs incurred in providing emergency response services to vehicle fires.

**NOW THEREFORE Be** it Ordained by the Board of Trustee of the Lisle-Woodridge Fire District, DuPage and Will Counties, Illinois, hereby amends its Ordinance #95-20 to read as follows:

**Section One:** When emergency response services are rendered by the Lisle-Woodridge Fire District in response to fire or threat of fire involving a vehicle owned by persons, businesses, or other entities who are not residents of the Lisle-Woodridge Fire District, the maximum charges to be assessed are as follows:

- A. \$250.00 per hour or a fraction thereof for each vehicle responding. Minimum one quarter (¼) hour.
- B. \$70.00 per hour, or a fraction thereof, for each firefighter responding to such a call. Minimum one quarter (¼) hour.

**Section Two:** The fire chief is hereby authorized to establish flat fees not inconsistent with the above listed fees, to waive any or all of the fees due from a person, business, or other entity under this ordinance. He may do so by policy or on an individual basis.

**Section Three:** For purposes of this Ordinance, "resident" is defined as someone who permanently resides in the District.

**Section Four:** All revenue from the charges assessed pursuant to this Ordinance shall be deposited in the general fund of the Lisle-Woodridge Fire District.

**Section Five:** Nothing in this Ordinance shall authorize the District to refuse to provide any service to any person, business, or other entity that has not paid for services previously provided or that owes money for services previously rendered.

**Section Six:** All ordinances and parts of ordinances in conflict or inconsistent with the provisions of this Ordinance are hereby repealed to the extent that they may conflict.

**Section Seven:** The invalidation of any section, part, provision, term or phrase of this Ordinance shall not affect the validity of the remaining sections of this Ordinance.


