ORDINANCE NO. 15-17

ORDINANCE LEVYING AND ASSESSING TAXES OF  
LISLE-WOODRIDGE FIRE PROTECTION DISTRICT  
DUPAGE AND WILL COUNTIES, ILLINOIS  
FOR 2015

**BE IT ORDAINED** by the Board of Trustees of the Lisle-Woodridge Fire Protection District  
as follows:

**Section 1:** That the sum of ***SEVENTEEN MILLION, NINE HUNDRED SEVENTEEN-THOUSAND, NINE HUNDRED FIFTEEN (\$17,917,915.00) DOLLARS*** be and the same is assessed and levied from and against all taxable property within the limits of the said Lisle-Woodridge Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2015, and are to be applied in liquidation of the appropriations heretofore made by Ordinance adopted by the Board of Trustees of the Lisle-Woodridge Fire Protection District at a meeting thereof regularly convened and held on November 24, 2015, and duly published as provided by law and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy", as follows:

**CORPORATE FUND**

Amount to be Raised by Tax Levy **\$7,876,266**

The foregoing amount is hereby levied for general corporate purposes.

**TORT LIABILITY FUND**

Amount to be Raised by Tax Levy **\$700,000**

The foregoing amount is hereby levied for tort liability purposes under and pursuant to the provisions of 745 ILCS 10/9-107.

**AUDIT FUND**

Amount to be Raised by Tax Levy \$0

The foregoing amount is hereby levied for audit expense purposes.

**AMBULANCE FUND**

Amount to be Raised by Tax Levy \$5,100,000

The foregoing amount is hereby levied for ambulance services purposes.

**ILLINOIS MUNICIPAL RETIREMENT FUND**

Amount to be Raised by Tax Levy \$30,500

The foregoing amount is hereby levied for Illinois Municipal Retirement Fund contribution and withholding purposes.

**SOCIAL SECURITY/MEDICARE FUND**

Amount to be Raised by Tax Levy \$111,000

The foregoing amount is hereby levied for Social Security and Medicare contribution and withholding purposes.

**FIREFIGHTERS' PENSION FUND**

Amount to be Raised by Tax Levy \$4,100,149

The foregoing amount is hereby levied for pension fund purposes. ***"Of this entire pension levy, the sum of \$102,504 is certified to be exempt from the Property Tax Extension Limitation Law pursuant to P.A. 93-689."***


**Section 3:** That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
